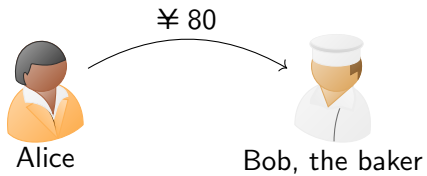

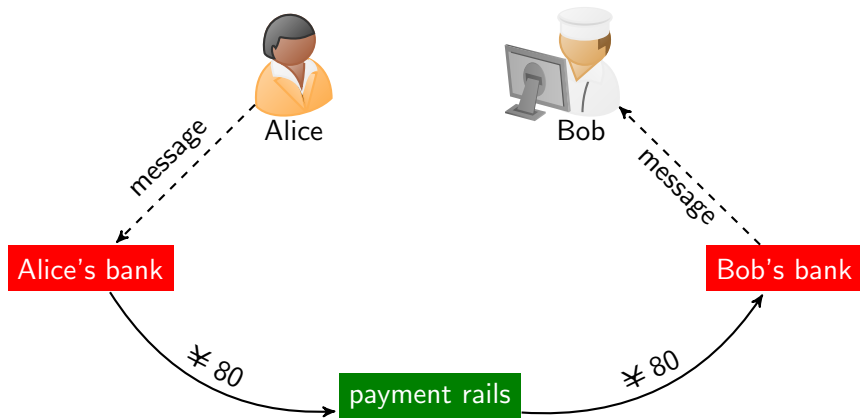

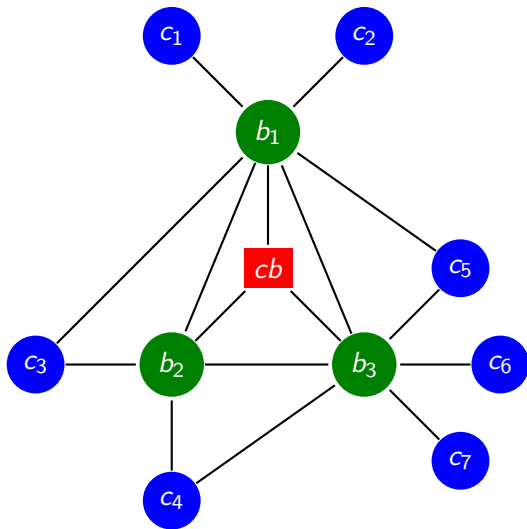
A payment



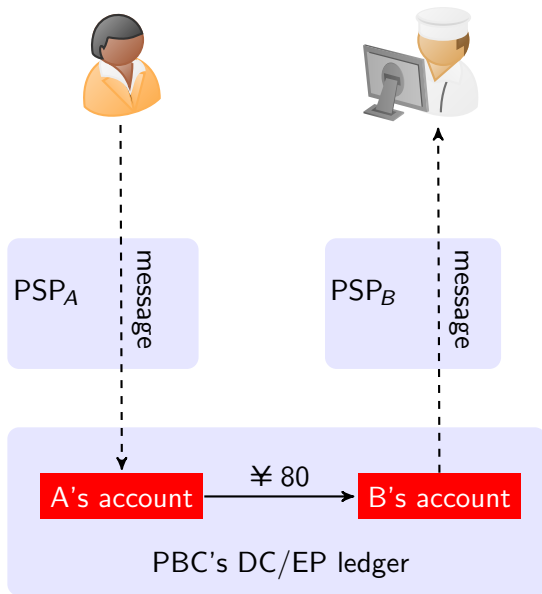
A conventional bank-railed payment



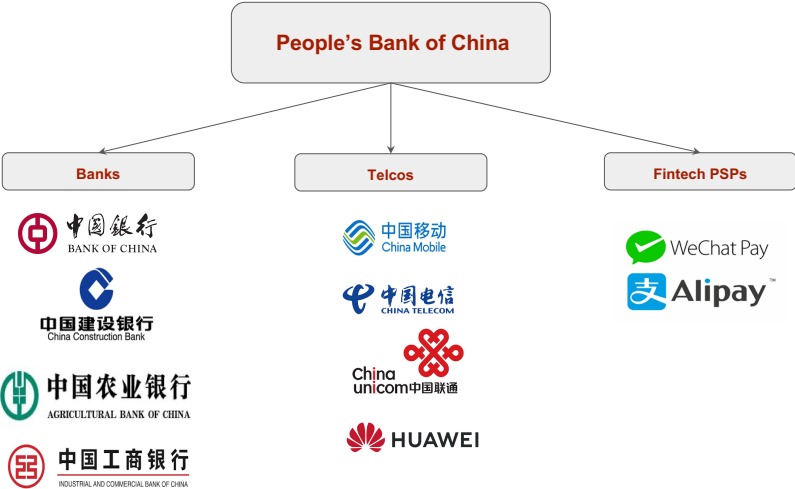
Bank payment rails



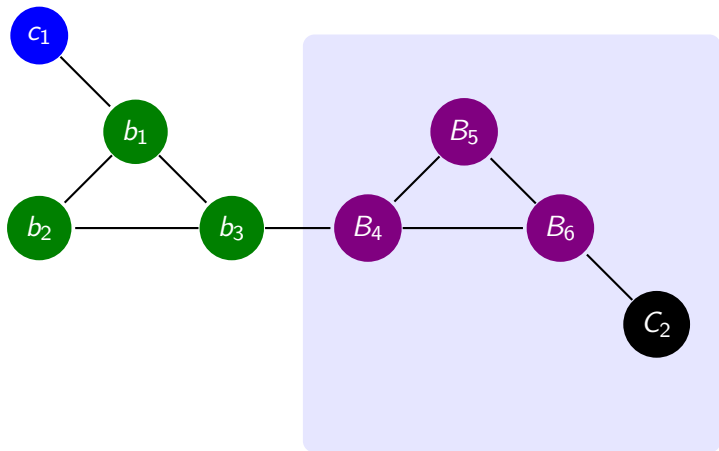
A DC/EP payment

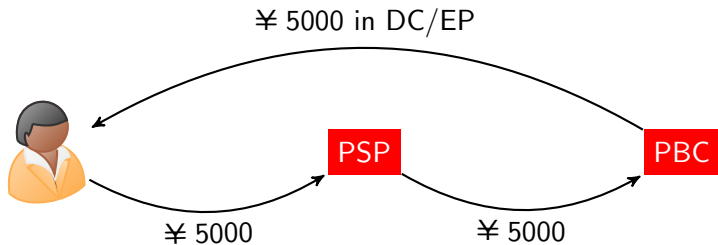

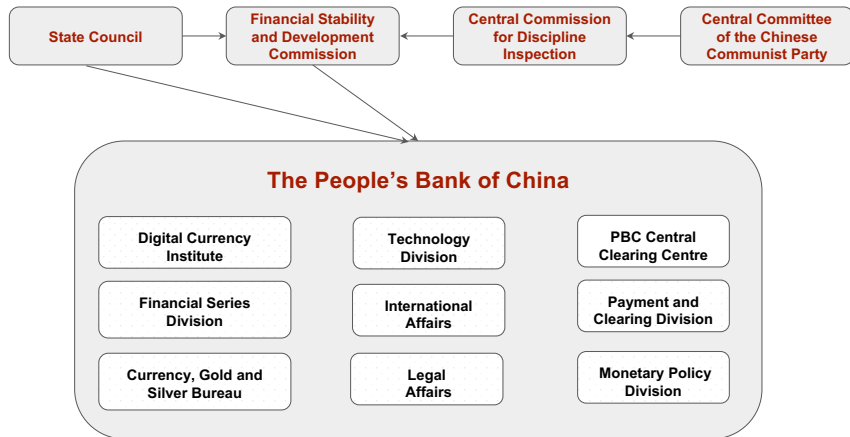

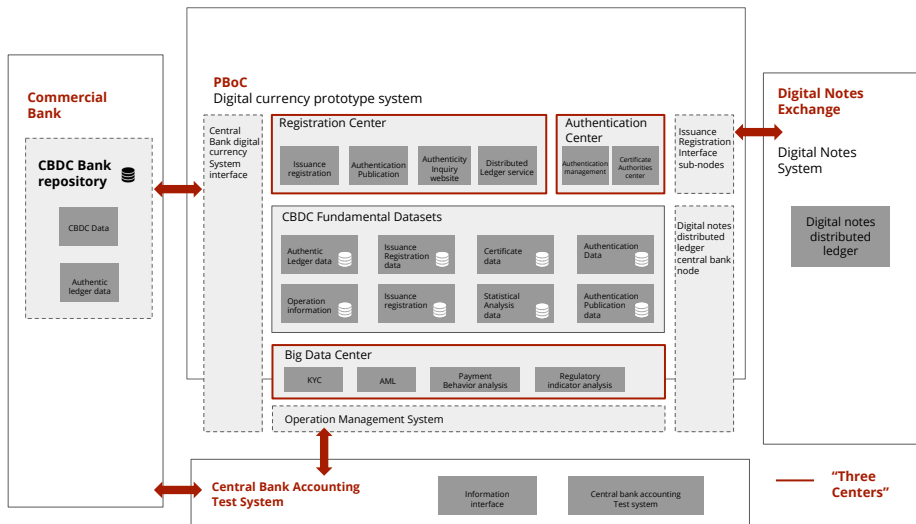
Appendix: Alice puts ¥ 5000 into her DC/EP account
